

INSIDESOURCES' GIVEAWAY OFFICIAL RULES

NO PURCHASE NECESSARY. VOID IN PUERTO RICO, US TERRITORIES AND WHERE PROHIBITED BY LAW.

- 1. ELIGIBILITY:** The InsideSources Giveaway (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and Washington, D.C. who are at least eighteen (18) years old at the time of entry. - 4. HOW TO ENTER:** During the Entry Period, enter by completing an InsideSources Reader Survey available at <https://www.surveymonkey.com/s/InsideSources>. At the end of the survey, enter your name, email address, and phone number.
- 5. WINNER DETERMINATION; ODDS:** Around 12:00:01 PM on Friday, June 20, 2014, Sponsor will randomly select ONE (1) winner from all eligible entries received during the Entry Period. Odds of winning a prize depend on the number of eligible entries received. Winners do not need to be present to win. Potential winner(s) will be notified by email or phone, using the information provided on Sponsor's request. Sponsor will then send to potential winner(s) by e-mail, a request for a mailing address. By entering, entrants give their express permission to be contacted by Sponsor through e-mail. Sponsor reserves the right to require winners to execute and return an affidavit of eligibility, publicity and liability release ("Affidavit") prior to awarding any prize. In the event: (a) potential winner cannot be reached or does not respond for whatever reason within three (3) business days of the date of first notification, (b) Affidavit is not returned within timeframe requested in Affidavit, (c) potential winner is found to be ineligible to enter the Sweepstakes or receive the prize, (d) potential winner cannot or does not comply with the Official Rules, (e) potential winner's prize notification is returned as undeliverable for whatever reason, or (f) potential winner fails to fulfill its obligations hereunder, the potential winner shall be disqualified from the Sweepstakes and an alternate potential winner may be selected, at Sponsor's sole discretion, from among the other eligible entries received.

GENERAL: By entering the Sweepstakes, entrant hereby waives and releases, and agrees to hold harmless Sponsor, and any of their affiliated and subsidiary companies, advertising and promotion agencies, and all of their respective officers, directors, employees, representatives and agents (collectively, the “Released Parties”) from and against any and all rights, claims and causes of action whatsoever that he or she may have, or which may arise, against any of the Released Parties for any liability for any matter, cause or thing whatsoever, including but not limited to any injury, loss, damage, travel complications, whether direct, compensatory, incidental or consequential, to person, including death, and property, arising in whole or in part, directly or indirectly, from his or her acceptance, possession, use or misuse of the prize, his or her participation in the Sweepstakes, or his or her participation in any prize- or Sweepstakes-related activity.

By entering or participating in the Sweepstakes, entrant agrees to be bound by these Official Rules and waives any right to claim any ambiguity or error in these Official Rules or the Sweepstakes itself. The Released Parties assume no responsibility for electronic hardware, programming or software malfunctions, or failures, or line connections, accessibility or availability, or technical failures of any kind, or unauthorized human intervention, or the incorrect or inaccurate capture of any entry or other information, or for the failure to capture any such information.
